# Campaign for Wise & Safe Investing® A statewide outreach program in

partnership with the Pennsylvania AARP Consumer Issues Task Force that provides

retirees and senior citizens information on how to recognize, avoid, and report financial fraud and abuse. Community presentations are offered through a grant from the Investor Protection Trust.



#### **Fraud Bingo**

BING O A fun and interactive presentation that teaches consumers about financial and investment related fraud by playing a

familiar game: Bingo! Players learn how to detect financial fraud by identifying scams affecting their own city or town, and learning techniques to protect themselves from this financial abuse. Organize your own game or ask us to help (groups of 25 or more).



Financial fraud prevention programming geared for retirees and seniors. Includes guest speakers from local, county, and

state government agencies. Fraud bingo is also included, conducted by volunteers from the Pennsylvania AARP Consumer Issues Task Force. This fast-paced event runs 2 1/2 to 3 hours and requires a minimum of 50 attendees.

#### **FinLit Forum**

A three-hour financial literacy, conference style program designed to address financial, investment, and other important life lessons

that are faced by high school and college students. Program includes guest speakers from state government agencies and nonprofit partners.

## **Elder Investment Fraud and Financial Exploitation Prevention Program** This research-based program educates

professionals who routinely work with

older Pennsylvanians to recognize when their older clients may be vulnerable to or victims of financial abuse, particularly those with mild cognitive impairment. The program also teaches professionals how to refer these at-risk patients to our department or to the local adult protective services office. It provides continuing education credits, especially in the category of Ethics, and was created by the Baylor College of Medicine and the Investor Protection Trust.

Training program for financial professionals to recognize and report financial abuse targeting their clients,

especially those suffering from cognitive impairment.
