ORDERED and DECREED that:

1. HLF Mortgage, Inc. is ordered to pay a fine of \$9,000 pursuant to Section 314(c) of the Mortgage Bankers and Brokers and Consumer Equity Protection Act (the "MBBCEPA"), 63 P.S. § 456.314(c), and Section 22(b) of the Secondary Mortgage Loan Act (the "SMLA"), 7 P.S. § 6622(b), for its multiple violations of the MBBCEPA and SMLA;

2. To the extent that HLF Mortgage, Inc. currently holds license nos. 5402 and 12592, under the SMLA and the MBBCEPA, respectively, said licensees are hereby revoked; and,

3. M. Carole Fisher, as a natural person or as a corporation or as any other form of organization of any kind whatsoever, is hereby prohibited from working in the mortgage loan business as regulated by the SMLA, 7 P.S. § 6601 *et seq.*, and the MBBCEPA, 63 P.S. § 456.101 *et seq.*, as a licensee, employee, independent contractor, agent, representative, or in any other capacity of any kind whatsoever, in any way whatsoever.
