WHEREAS, on November 14, 2005, the Pennsylvania Department of Banking and Securities (Department) issued to Galen M. Martin an Order to Show Cause (OSC) containing allegations of violations of the Pennsylvania Securities Act of 1972 (1972 Act), 70 P.S. 1-101 et seq.; and

WHEREAS, the OSC was issued on November 14, 2005; and

WHEREAS, on or about November 15, 2005, the aforesaid OSC was duly served on Galen M. Martin; and

WHEREAS, an amended OSC was issued on May 3, 2006; and

WHEREAS, on or about May 4, 2006, the aforesaid amended OSC was duly served upon Galen M. Martin; and

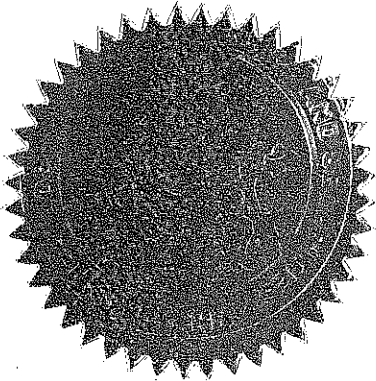
WHEREAS, on or about May 24, 2006, Galen M. Martin submitted an Answer to the amended OSC; and

WHEREAS, the staff of the Department has recommended the OSC and the amended OSC be vacated as to Galen M. Martin; and

WHEREAS, the Department finds that it is necessary and appropriate in the public interest and for the protection of investors, consistent with the purposes fairly intended by the policy and provisions of the 1972 Act, to issue this Order to Vacate Order to Show Cause and the amended Order to Show Cause;

NOW, THEREFORE, the Commission directs that the Order to Show Cause and amended Order to Show Cause issued in this proceeding against Galen M. Martin be and is hereby VACATED.
