ORDER TO WITHDRAW SUMMARY ORDER TO CEASE AND DESIST

WHEREAS, the Department of Banking and Securities (the "Department") is the Commonwealth of Pennsylvania's administrative agency authorized and empowered to administer and enforce the Pennsylvania Securities Act, 70 P.S. § 1-101 et seq. ("1972 Act"); and

WHEREAS, the Bureau of Licensing, Compliance, and Enforcement (the "Bureau") is primarily responsible for administering and enforcing the 1972 Act for the Department; and

WHEREAS, On February 7, 2012, the Pennsylvania Securities Commission ("PSC")* issued to Nevada Solar First TD, LLC; Rising Energy Systems Corp.; and Danny Katzka (collectively "Respondents") a Summary Order to Cease and Desist ("Summary Order"), finding a violation of Section 201 of the 1972 Act, 70 P.S. § 1-201 in the offer of limited liability company membership interests (Interests); and

WHEREAS, the Respondents filed a written request that an administrative hearing be held regarding the Summary Order pursuant to their rights under Section 607 of the 1972 Act, 70 P.S. §1-607; and


WHEREAS, an administrative hearing was not held in this matter; and

WHEREAS, the Respondents have represented in writing to the staff of the Bureau that no sale of the Interests has been made in Pennsylvania nor will a sale of the Interests be made in Pennsylvania in the future; and

WHEREAS, based upon the afore-referenced, staff of the Bureau has recommended the Summary Order be withdrawn as to the Respondents; and

WHEREAS, after due deliberation, the Bureau finds it necessary and appropriate, and consistent with the purposes fairly intended by the policy and provisions of the 1972 Act to issue this Order to Withdraw Summary Order to Cease and Desist.

NOW, THEREFORE, the Commission directs that the Summary Order to Cease and Desist issued in this proceeding against Respondents be and is hereby WITHDRAWN.
