# CONSENT AGREEMENT AND ORDER

The Commonwealth of Pennsylvania, acting through the Department of Banking and Securities ("Department"), Compliance Office ("Office"), has reviewed the business practices of Maxie Joel Wozniak ("MJW") and its officers, employees, and directors. Based on the results of its review, the Office concludes that MJW operated in violation of the Consumer Credit Code ("CCC") as it relates to motor vehicle sales finance, 12 Pa.C.S. § 6201 et seq. The parties to the above-captioned matter, in lieu of litigation, hereby stipulate that the following statements are true and correct in the settlement of the above-captioned matter and, intending to be legally bound, hereby agree to the terms of this Consent Agreement and Order ("Order").

#### BACKGROUND

- 1. The Department is the Commonwealth of Pennsylvania's administrative agency authorized and empowered to administer and enforce Chapter 62 of the CCC, 12 Pa.C.S. § 6201 et seq.
- 2. The Office is primarily responsible for administering and enforcing the CCC for the Department.
  - 3. MJW is licensed as an Installment Seller #29984 under the CCC.
  - 4. MJW is located at 3810 Pittston Avenue, Moosic, PA 18507.

5. On November 6, 2023, an examiner from the Department commenced a routine examination of MIW at its principal place of business.

## Gramm-Leach Bliley Act

- 6. Pursuant to Section 6803 of the Gramm-Leach Billey Act, 15 U.S.C. § 6803, MJW is required to develop, implement, and maintain a written information security program.
- 7. From in or about June 3, 2019 until December 21, 2023, MJW failed to create an information security program as required by 15 U.S.C. § 6803.

## Authority of the Department

- 8. The CCC grants the Department the authority to issue orders as may be necessary for the enforcement of the CCC. 12 Pa.C.S. § 6203(a)(5).
- 9. Section 6218(a)(13) of the CCC states that the Department may revoke or suspend any license when the licensee engaged in an illegal practice or conduct, 12 Pa.C.S. § 6218(a)(13).
- 10. Section 6274 of the CCC provides that "[a] person required to be licensed under this chapter that violates this chapter, directs a violation of this chapter or engages in an activity for which a license could be suspended or revoked under section 6218 (relating to revocation or suspension of license) shall be subject to a civil penalty levied by the department of not more than \$2,000 for each offense." 12 Pa.C.S. § 6274.

#### VIOLATIONS

11. MJW violated 15 U.S.C. § 6803 when it failed to develop, implement, and maintain a written information security program.

#### RELIEF

12. Fine. MJW agrees to pay a fine of five hundred dollars (\$500). Payment is due within thirty (30) days of the Effective Date of the Order as defined in paragraph 20 below. The fine payment shall be made through the Department portal at https://www.portal.dobs.pa.gov.

#### 13. Corrective Action.

- a. Upon the Effective Date of this Order, MJW shall maintain a written information security program at all times.
- b. MJW shall comply with the CCC at all times.

#### **FURTHER PROVISIONS**

- 14. Consent. MJW hereby knowingly, willingly, voluntarily and irrevocably consents to the entry of this Order pursuant to the Department's order authority under the CCC and agrees that it understands all of the terms and conditions contained herein. MJW, by voluntarily entering into this Order, waives any right to a hearing or appeal concerning the terms, conditions and/or penalties set forth in this Order.
- 15. <u>Consumer's Rights</u>. This Order shall not limit or impair any consumer's rights under CCC. 12 Pa.C.S. § 6236.
- 16. <u>Publication</u>. The Department will publish this Order pursuant to its authority in Section 302.A.(5) of the Department of Banking and Securities Code, 71 P.S. § 733-302.A.(5).
- 17. <u>Entire Agreement</u>. This Order contains the whole agreement between the parties. There are no other terms, obligations, covenants, representations, statements, conditions, or otherwise, of any kind whatsoever concerning this Order. This Order may be amended in writing by mutual agreement by the Office and MJW.
- 18. Binding Nature. The Department, MJW, and all officers, owners, directors, employees, heirs and assigns of MJW intend to be and are legally bound by the terms of this Order.
- 19. <u>Counsel</u>. This Order is entered into by the parties upon full opportunity for legal advice from legal counsel.
- 20. <u>Effectiveness</u>, MJW hereby stipulates and agrees that the Order shall become effective on the date that the Office executes this Order ("Effective Date").

## 21. Other Enforcement Action.

- a. The Department reserves all of its rights, duties, and authority to enforce all statutes, rules and regulations under its jurisdiction against MJW in the future regarding all matters not resolved by this Order.
- b. MIW acknowledges and agrees that this Order is only binding upon the Department and not any other local, state or federal agency, department or office regarding matters within this Order.
- 22. <u>Authorization</u>. The parties below are authorized to execute this Order and legally bind their respective parties.
- 23. Counterparts. This Order may be executed in separate counterparts and by facsimile or electronic format.
- 24. <u>Titles</u>. The titles used to identify the paragraphs of this document are for the convenience of reference only and do not control the interpretation of this document.


