## CONSENT AGREEMENT AND ORDER

The Commonwealth of Pennsylvania, acting through the Department of Banking and Securities ("Deparment"), Compliance Office ("Office"), hins revicwed the business practices of M \& S Sales \& Service, Inc. ("M \& S") and its officers, employees, and directors. Based on the resulis of its review, the Office concludes that $M \& S$ operated in violation of the Consumer Credit Code ("CCC") as it relates to motor' vehicle sales finance, 12 Pa.C.S. § 6201 elseg . The parties to the above captioned matter, in lieu of litigation, horeby stipulate that the following slatements are true and correct in the settenent of the above-captioned matter and, intending to be legally bound, hereby agree to the terms of this Consent Agreement and Order ("Order"),

## BACKGROUND

1. The Department is the Commonvealth of Pennsylvania's administrative agency authorized and empowered to administer and enforce Chapter ( 22 of the CCC, 12 Pa.C.S. § 6201 et seq.
2. The Ofrice is primarily responsible for administering and enforing the CCC for the Department.
3. M \& S is licensed as an Installment Seller \#0988 under the CCC.
4. 'M \& S is located al 3385 Division Hwy,, New Holland, PA 17557.
5. On November 1, 2023, an exaniner from the Department commenced a routine examination of $M \& S$ at ifs principal place of business.

Identity Theft Prevention Program
6. Pursuant to 16 CPR Part $681, \mathrm{M}$ \& S is required to develop and implement a written idencity theft prevention program to identify, prevent, and motigate identity theft.
7. From in or about March 4, 2020, until December 27, 2023, M \& S failed to create an identity theft prevention program as required by 16 CFR Part 681.

## Authority of the Depratment

8. The CC.C. grants the Deparment the authonty to issue orders as may be necessary for the enforcement of the CCC. 12 Pa.C.S. $\$ 6203(\mathrm{a})(5)$.
9. Section $6218(a)(13)$ of the CC.C states that the Department may revoke or suspend any license when the licensee engaged in an illegal practice or conduct. 12 Pat.C.S. § 6218 (a)(13).
10. Section 6274 of the CCC provides that " $[a]$ person required to be licensed under this chapter that violates this chapter, directs a volation of this chapter or engages in an activity for which a license conld be suspended or revoked under section 6218 (relating to revocation or suspension of license) shall be subject to a civil penalty levied by the department of not more than $\$ 2,000$ for each offense," 12 Pa.C.S. § 6274.

## VIOLATION

11. M \& S vinated 16 CFR Part 681 when it tailed to have a written identity thef prevention program to identify, prolect, and mitigato identity theft.

## RELIEF

12. Fine, M \& S agrees to pay a tine of five hundred dollars (\$500). Payment is due wilhin Wirly (30) days of the Effective Date of the Order as defined in paragraph 20 below. The fine payment shall be made through the Department portal at hups://www,portal,dobs.pa.gov,
13. Corrective Action.
a. Upon the Effective Dato of this Order, M \& S shall maintain a written identity theft prevention progrum at all times,
b. $\quad M \& S$ shall comply with the CCC at all times.

## FURTHER PROVISIONS

14. Consent. M \& S hereby knowingly, willingly, voluntarily and irrevocably consents to the entry of this Order pursuant to the Deparment's order authonity under the CCC and agrees that it understands all of the terms and conditions contained herein. $M \& S$, by voluntarily entering into this Order, waives any right to a hearing or appeal concerning the terms, conditions and/or penalties set forth In this Order.
15. Consumer's Rights. This Order shall not limit or impair any consumer's rights under CCC. 12 Pa.C.S.S. §. 6236.
16. Publication. The Department will publish this Order pursuant to its muthority in Section 302.A.(5) of the Department of Banking and Securitics Code. 71 P.S. § 733.302.A.(5).
17. Entire Agreement. This Order contains the whole agreement betiveen the parties. There are no other terms, obligations, covenants, representations, statements, conditions, or otherwise, of any kind whatsoever concerning this Order. This Order may be amended in writing by mutual agreement by the Office and M \& S.
18. Binding Nature. The Department, M \& $S$, and all officers, owners, directors, employees, heirs and assigns of $M \& S$ intend to be and are legally bound by the terms of this Order.
19. Counsel. This Order is entered into by the parties upon full opportunity for legal advice from legal counscl.
20. Effectiveness. $M$ \& $S$ hereby stipulates and agrees that the Order shall become effective on the date that the Office cxecutes this Order ("Effective Date"),
21. Other Enforcement Action.
a. The Department reserves all of its rights, duties, and authority to enforce all statutes, rules and reguations under its juriscliction against $M \& S$ in the future regarding all matters not resolved by this Order'
b. M \& S acknowledges and agrees that this Order is only binding upon the Deparment and not ayy other local, state or federal agency, department or office regarding matters within this Order
22. Authorization. The parties below are authorized to execute this Order and legally bind their respective parkies.
23. Counterparts. This Order may be executed in separate counterparts and by facsimite or electronic format.
24. Titles. The titles used to identify the paragraphs of this document are for the convenience of reference only and do not control the interpretation of this document.

WHEREFORE, in consideration of the foregoing, inchading the reottal paragraphs, the Department of Banking and Securities, Compliance Office and M \& S Sales \& Service, Inc, intending to be legally bound, do hereby execute this Consent Agreement and Order
