Failure to file a petition for review within 30 days of the mailing date of this Oxder will result in this Final Order becoming final and unappealable, The telephone number for the Commonwealth Court is 717-255-1650.

All Commonwealth Coutt filings must be made with the Cout's filing office in Harrisburg. Piling must be made in person, by mail as provided by general tules, or electrontcally via the PACFile appellate court electronic filing system. The address of the Court is as follows:

It is hereby ORDERED:

1. CreditAssoclates, LLC, will not maket, solleit, offer to provide or provide debt settlement services to Pemsylvania residents for a fee or other consideration until such time that CreditAssociates, LLC is licensed under the Debt Settiement Services Act; and,

2 CreditAssociates, LLLC, will pay an assessment of $\$ 10,000$ to the Department of Bauking and Seciurities.

Payment of the penalty shail be by certified check, attomey's check, or U.S. Postal Service money order, made payable to "Commonwealth of Pennsylvania," and shall be mailed within thisty (30) days of the effective date of the Commission's Final Order to this matter to the counsel for the Compliance Office at:
