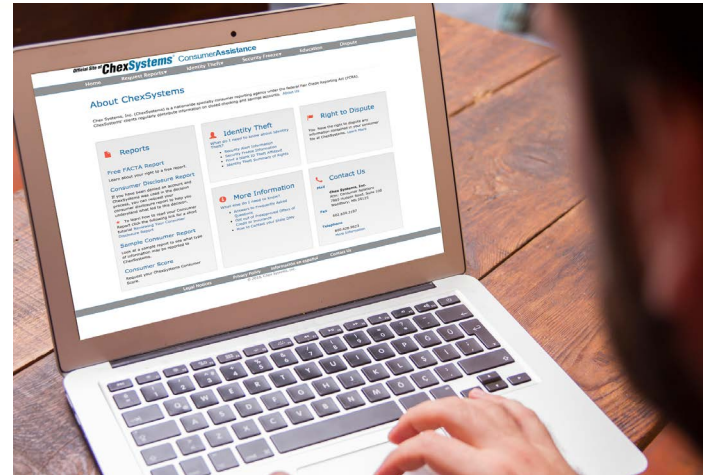




# ChexSystems

News about credit reports is hard to avoid – and understanding your Credit Reports and Scores is essential for everything from employment to housing to insurance, and of course, to getting credit (loans). But did you know there is a completely separate, lesser-known report, issued by ChexSystems, that can also impact your ability to open an account with a bank or credit union?



## What is a ChexSystems report?

ChexSystems, Inc. (ChexSystems) is a specialty consumer reporting agency that compiles and reports information from member banking organizations.

Governed by the Fair Credit Reporting Act, a ChexSystems report will list new account applications you've made, outstanding banking fees/debt you may owe, and if you've had charge-offs, returned checks, and involuntary account closures. Other information appearing on your report could include: felony records, property ownership and liens, bankruptcies, and evictions.

## Why is it important?

Banks and credit unions use ChexSystems reports to evaluate applications for banking services, i.e., checking and savings accounts. Having a checking or savings account is important because many employers require an account for direct deposit of your pay, other financial transactions may require them, and having one may offer more convenient access to other deposits, such as tax refunds. The accuracy of the information in your ChexSystems report can mean the difference between being approved or being denied a banking account. Your report may also reveal information about suspected fraud, check orders, and credit inquiries and freezes that you have reported or that have been reported in your name.

You can order your ChexSystems report once a year by simply filling out the form (on the back of this page) and sending it to:

Once you receive your report, carefully review the information to make sure it is accurate. If you find errors, **you must write a letter** clearly explaining the mistakes. Be sure to include copies of any supporting documents you may have and send it to both ChexSystems and the company that reported the issue.
